ORDER OF THE REGULATOR NO. 2018/T46

APPROVAL OF DIGICEL SAMOA LIMITED NEW DATA TARIFFS FOR PREPAID AND POST-PAID SERVICES

The Regulator has instructed Digicel Samoa Limited ("Digicel") to desist from continuing its Supa Seki Data Promotion given that the Office of the Regulator's records show that Digicel did not apply for regulatory approval for the tariffs included in its Supa Seki Data Promotion.

Digicel Samoa Limited ("Digicel") pursuant to the Order of the Regulator 2017/T32 is the dominant service provider in the retail mobile services market including services on mobile voice and mobile data services, and ancillary services typically bundles with mobile voice and data services such as mobile broadband cellular radio services market. The Supa Seki Promotion associated with services Digicel Samoa Limited provides using its cellular radio network and accordingly, any tariffs associated with the promotion should have been approved by the Regulator prior to implementation.

On 19th March 2018 Digicel submitted its new data tariffs plans for prepaid and post-paid for the Regulator's approval, in accordance with section 40 of the Telecommunications Act 2005 ("Act")

The mobile data retail tariffs have been approved by the Regulator in consideration of:

- 1) Digicel Samoa's submissions;
- 2) The objectives of the Act;
- 3) Provisions of the Act regarding tariffs in particular section 40(3); and

The Regulator advises that:

- 1) All tariffs and rates for services provided by a dominant service provider for the services for which they have been determined or deemed dominant must first be approved by the Regulator;
- 2) Only approved tariffs shall be applied for those services for which the provider has been deemed dominant;
- 3) New tariff will apply automatically for all subscribers for the regulated services;

Accordingly, the Regulator issues this Order No. 2018/T46 in endorsement of the tariffs and charges.

The tariffs specified in this Order shall be the tariffs specified for the purpose of this Order until such times as it might be amended by the Regulator.
